SEATTLE ANGEL INVESTORS AT NWEN'S START-UP COMPETITION VOTE SUNCREST™ FARMS INTO THE TOP 5 OUT OF 50 COMPETITORS DURING THEIR BI-ANNUAL FIRST LOOK FORUM AT THE HUB IN DOWNTOWN SEATTLE.

SEATTLE, WASH. —— (TUESDAY, Oct. 16, 2012) —— SUNCREST™ FARMS has been voted one of the "Top 5" new entrepreneurial start-ups in the Pacific Northwest after a 6-week long competition hosted by Seattle's Northwest Entrepreneur Network (NWEN).

Fifty-two start-ups submitted their business plans this fall. After several rounds of in-depth coaching and two rounds of cuts, 12 early-stage, growth-oriented start-ups from every segment of innovation in the Pacific Northwest — presented to the investor community for the first time. More than 140 people attended Tuesday night's event, with representatives from over 20 venture firms, investment firms, angel groups and individual investors.

Suncrest's 5-minute pitch described them as a Seattle-based cleantech company that uses proprietary hydroponic technology to grow lettuce and leafy greens in large ponds of nutrient-rich water, without soil. The company intends to build a network of high-yield greenhouse facilities across the U.S. within 100 miles of major metropolitan areas to provide lettuce that is "Always Local. Always Fresh."

"Right after presenting, an investor came up and said — 'your pitch was #1 in my book." said Suncrest's Founder and CEO, James Day. "All I could think was, please vote with your checkbook!" After being invited back as one of the Top 5, Day described some of the company's proprietary technology called Hydroponics 2.0™, followed by a Q&A by several prominent venture capitalists.

Suncrest is pre-revenue with plans on building modular control systems in the Seattle area to accelerate the development of facilities across the U.S. The company plans to start operations in Dallas, Texas, where Day owns 55,000SF of greenhouses, and where it intends to build its first major production facility which will also server as a training center for hydroponic growing teams from all over the country — and eventually, the world.

Suncrest's first facility is planned for Dallas, TX where Day owns a large greenhouse facility that will be converted to hydroponics once funded.
